The CDC Company Lines will be attending three competitions in March and April of 2018!

***Please note:** The Quarter 2 statements will include all competition fees for this season. (Due: December 5, 2017)

PLEASE MARK/ADJUST YOUR CALENDERS NOW

All three competitions are mandatory for all Company dancers in a Small Group (and/or Large Group) to attend...no exceptions! Solo dancers are **not** required to do all three competitions – only one competition is required. But, participating in all three competitions is highly recommended.

Please let me know by: **December 5, 2017** if a solo routine will not be performed at a competition!

When will you find out the exact day and time your dancer(s) will perform their routine for that weekend?

Unfortunately, competitions will not give studios the specific performance days and times until the week before (sometimes two weeks before...*if we are lucky*) the actual competition date. The competitions base the entire weekend schedule on how many entries they receive in each category; therefore, they wait to give this information out until the last minute. I email you as soon as I receive this information.

Hotel information is given in the case your family chooses to stay in Minneapolis/St. Paul ... but please know – **staying overnight is not required!** In many cases, it will be possible to drive over to the cities and back to Rice Lake in the same day, unless your dancer is involved in multiple routines. For your convenience, I did include a nearby hotel and the contact information.
